#### **October Presentation: Jo Haemer**

Jo Haemer has been working in the field of jewelry and metal arts for over fifty years. She is a second-generation artist who studied jewelry in high school and graduated early to study art at the University of Oregon. She is a Liturgical Silversmith and specialist in old world techniques, and was the first female journeyman bench worker in the Jeweler's Union. Jo has worked in various trade and manufacturing shops and was instrumental in building the Portlandia Statue.



She has also started using Continuum silver to make high-end custom eyewear, some examples of which can be seen on Instagram at <a href="mailto:@timothywgreenfinejewelry">@timothywgreenfinejewelry</a>, the account she shares with her husband Timothy W. Green. Jo, who teaches privately and used to teach at the Multnomah Arts Center, will be talking to us about education and the arts.

## What is Taborspace?

Centrally located with a dedicated parking lot, <u>Taborspace</u> is a community gathering place containing meeting rooms, a coffeeshop, and a functioning Presbyterian church. The Portland institution has served the public for eleven years and hosts an average of 120 meetings every week. Pending the Multnomah Arts Center's full reopening, it's where CMAG will resume its own in-person meetings.

#### Call for Artists: 2022 Circle of Art

## February Class: Enameling with Anne Havel

CMAG will be hosting a three-hour enameling class on Zoom in February 2022. The instructor will be renowned enameler Anne Havel, an expert in sgraffito techniques. Students will learn how to sift and apply counter enamel, use liquid enamel for sgraffito, and, time permitting, wet-pack transparent enamels for color. Metal prep, forming, counter enameling for strength, torch safety and options, tip sizes, multiple firing station set-up options, and heat containment will all be covered.

The class, open to CMAG members at \$100 and the general public at \$125, is being offered at a very reasonable cost on the condition that we meet the minimum of 20 students. If the minimum is not met two weeks before the class date, the class will be canceled and all participants will be fully refunded. Registration is open now.


# **Book Review** by Madeleine Moore

# ECO Jewelry Handbook: A practical guide for a Healthy, Safe and Sustainable Studio

#### **Author: Christine Dhein**

Christine Dhein defines "Eco Jewelry" as "jewelry and other forms of metalwork made from responsibly sourced materials in a studio that uses safe, healthy, and environmentally friendly practices". Her 2018 Eco Jewelry Handbook grew out of the Bay Area Green Jewelry Studio Project, which Dhein founded in 2013 to help instructors create more eco-friendly classrooms. She divides her book into three parts: Health + Safety, Bench Practices, and Materials Sourcing, plus an appendix at the end.

Health + Safety is the longest section. It compares brands of commonly used chemicals, assigning them one to five flowers (that's "Poor Choice" to "Best Choice") and a health rating from one to four – that's "Exposure will cause irritation with only minor residual injury" to "Very short exposure can cause death or major residual injury". Dhein tackles flux, pickle, patina chemicals, and solvents, and provides a guide to grouping chemicals for safe storage. She then moves on to an overview of various kinds of safety equipment (with no brand comparison), and finishes with some stretching exercises to reduce muscle strain.



Bench Practices opens with the cradle-to-grave concept of perpetually reusing materials in closed loops, and focuses on capturing and recycling precious metal scrap. Materials Sourcing compares artisanal and small-scale mining with large-scale mining (it's all bad) and discusses fair trade standards. Our very own Columbia Gem House makes an appearance for its fair trade protocols, and Dhein provides a list of questions to ask suppliers. There is a list of suppliers who have been recommended for their commitment to industry standards and use of third-party certification, including Open Source Minerals, The American Pearl Company, and Stuller.

The book concludes with an action plan and bibliography for further reading. Further reading is required on most of the subjects covered, even on relatively straightforward topics like flux comparison. Upon reading that overexposure to Cupronil can cause kidney and liver damage, one's first question might be: how much exposure is overexposure? Is this something that only affects workers at the Cupronil plant? That question isn't answered in this book. It's also not clear that Dhein's risk assessment is within the mainstream; she recommends using gloves with even the least toxic fluxes, which almost no jewelers do. On the other hand, perhaps we all pay for it in old age.

Overall, the slim book is a good introduction to safety and responsibility in the workshop, and even experienced jewelers will probably learn something they didn't know before.
